Property tax Installment 1 payments for the City of Marshfield are due January 31, 2026.



Please note: The U.S. Postal Service has changed its mail postmarking processes. It's no longer the date that USPS first touches it. It's stamped at the sorting centers. If property owners wait until the last minute (for example, the last week in January), then some of the mail might be postmarked after January. If the letter is postmarked after January, the payment is considered delinquent.

To avoid delays or penalties, we strongly recommend mailing payments early and planning ahead.

## CITY ACCEPTING SEALED BIDS FOR THE SALE OF ASH TREE LOGS

The City of Marshfield is accepting sealed bids for the sale of ash tree logs located in the southern portion of Braem Park along East Grant Street.

Bids must be submitted to City Hall, 207 W. 6th Street, by 4:00

p.m. on Wednesday, February 11, 2026. Bids will be opened immediately thereafter and publicly read in the Public Conference Room.

The ash logs may be viewed beginning January 31, 2026. Bids will be accepted on a per-pile basis, and all logs must be removed by the end of the day on March 1, 2026. Cutting of logs within the park will not be permitted.

## WINTER PARKING REMINDER: HELP KEEP STREETS CLEAR

To support snowplowing, ice control, and emergency access during winter weather, the City of Marshfield reminds residents of seasonal parking restrictions.

From November 1 through April 30, parking is not allowed on any city street

between 2:30 a.m. and 6:00 a.m. This overnight restriction helps Public Works crews safely and efficiently clear



snow and ice from roadways.

Parking in city-owned parking lots is also prohibited overnight between 1:00 a.m. and 6:00 a.m.

## Finance Committee Reviews Draft Citywide Procurement Policy

Tuesday, Jan. 20 — The city’s Finance, Budget and Personnel Committee reviewed a draft overhaul of its procurement policy Tuesday night, marking what several officials described as a significant step toward improving transparency, accountability, and financial oversight in how the city purchases goods and services. Finance Director Jennifer

Selenske presented the revised policy, which consolidates and replaces two existing policies governing procurement of goods, services, and professional services. The proposal establishes a uniform, citywide framework intended to ensure competitive purchasing, responsible stewardship of public funds, and compliance with state, federal, and local laws, including federal regulations governing grant-funded purchases.

Selenske emphasized that the draft was presented for feedback only and not for approval. “I’m looking for feedback that overall

the policy aligns with your expectations, that it’s presented logically and easy to follow, and that it covers everything on your mental checklist,” she told the committee.

**Key Policy Changes**  
Under the draft policy, department heads, with approval from the city administrator, would be authorized to purchase goods and services up to \$25,000 annually and professional services up to \$15,000 annually, provided the purchases are budgeted and meet competitive requirements. Larger purchases would require escalating levels of review, including committee and Common Council approval for higher-dollar contracts.

The policy outlines clear purchasing thresholds:

- Purchases under \$10,000 would require only department head approval.
- Purchases between \$10,000 and \$25,000 would require written quotes and administrative approval.
- Purchases exceeding \$25,000 would require committee and council approval, with sealed bids required for purchases over \$50,000

Professional services would generally encourage competitive requests for proposals, with council approval required for contracts exceeding \$50,000.

Certain services — including legal counsel, insurance, and municipal advisory services — were identified as potential exemptions, a provision that prompted extended committee discussion. Oversight and Ethics Provisions. The draft policy also reinforces ethical standards, including prohibitions against splitting

purchases to avoid approval thresholds, restrictions on accepting gifts from vendors, and requirements to avoid real or perceived conflicts of interest. Vendors must not be delinquent or debarred, and confidentiality must be maintained during procurement processes while still complying with Wisconsin’s open records law.

Unauthorized purchases could result in disciplinary action or personal liability, according to the policy. Contracts would not be binding unless signed by authorized officials, with the mayor retaining statutory authority to sign contracts unless otherwise authorized by the council.

**Committee Feedback**  
Several committee members praised the draft as a major improvement. “This is a huge step forward,” one member said, thanking Selenske for the work put into the revision.

Committee members also raised questions about how often exempted services such as insurance brokerage should be competitively bid, with suggestions ranging from periodic reviews every five years to more frequent evaluations depending on cost increases. Others emphasized the importance of ensuring local vendors are aware of bidding opportunities and have a fair chance to compete.

Selenske said staff already posts requests for proposals and bids on the city’s website but acknowledged that outreach and communication could be improved to better inform local businesses.

**Next Steps**  
Selenske indicated that feedback from the committee would be incorporated into



a revised draft before the policy returns for formal consideration. The committee took no action on the policy Tuesday night. The meeting concluded with no items added for future agendas, and the committee adjourned following a unanimous vote.

**Faith Meyers Highlights Oversight, Transparency in Marshfield School Board Bid**

MARSHFIELD — Attorney and parent Faith Meyers is seeking a seat on the Marshfield School Board, citing a commitment to clear governance, responsible budgeting, and improved communication between the district and the community.

Meyers, who has lived in Marshfield since 2018, is the parent of three children currently enrolled across the district’s elementary, middle, and high schools. During a recent “Get to Know” interview, she said her decision to run was driven by a desire to strengthen public understanding of how school board decisions are made and to reduce misinformation surrounding district operations

“I care deeply about public education and about making sure our community understands how our schools actually function and how decisions are made,” Meyers said.

**Background in Law and Education**

Professionally, Meyers is an attorney and the owner of Meyers Family Law. Her background also includes

direct experience within the school system, having worked as a special education assistant at the high school level and as a substitute teacher while attending law school. She has also been active as a volunteer through the Grant Elementary PTO and district referendums.

Meyers said those experiences give her a multifaceted view of the district — as a parent, educator, and policy professional.

“As an attorney, I’m trained to read policy carefully, ask the right questions, and make decisions based on facts, not emotion,” she said

**Emphasis on Board Oversight**



Meyers repeatedly emphasized that she views the school board’s primary responsibility as oversight rather than day-to-day management. She said the board should focus on setting policy, approving budgets, establishing long-term goals, and evaluating the superintendent, while leaving operational decisions to district administrators.

“When a board member stays focused on oversight and the administrative team stays focused on management, accountability is clearer and decisions are more consistent,” she said

She also expressed interest in spending time in schools if elected, noting that

understanding classroom environments firsthand can inform better policy decisions.

**Priorities: Trust, Academics, and Student Well-Being**

If elected, Meyers said her top priorities would include strengthening trust between the district and the community, maintaining strong academic standards, and supporting student well-being.

She pointed to open board meetings and publicly available materials as evidence of transparency, but said accessibility and clarity remain challenges.

“Simply making information available doesn’t always mean it’s easily understood,” she said, adding that improved communication could help residents feel

more informed and connected to district decisions

Meyers also highlighted the importance of extracurricular activities in supporting both academic success and student mental health, noting her own children’s involvement in programs ranging from music and robotics to student government and academic competitions.

**Budgeting and Stewardship**

On fiscal issues, Meyers said she would approach budgeting with “stewardship and accountability,” emphasizing long-term sustainability and student outcomes over short-term solutions.

She praised the district’s

recent efforts to reduce costs without cutting programs, citing a technology leasing decision that is expected to lower annual expenses. At the same time, she said community understanding of school finance is critical when weighing spending decisions against tax impacts.

“When the community understands how the district is funded and what the real impacts of budget decisions are, it leads to better outcomes for everyone,” she said

**Leadership and Decision-Making**

Drawing from her legal career, Meyers said she is accustomed to navigating high-conflict situations and making decisions without perfect outcomes. She said that experience has reinforced the importance of process, clarity, and long-term thinking — skills she believes translate directly to school board service.

Asked why voters should trust her, Meyers pointed to her combined experience as a parent, educator, and attorney, as well as her respect for the distinct roles of the board and district administration.

“My goal is to move the district forward in a constructive way, build on its strengths, and keep students at the center of every decision,” she said
